1. Reviewed Minutes of November 23, 2023, meeting: A motion to adopt the minutes of November 23, 2023, was made by Randal Miiler and seconded by Tiffany Lowe.

2. Old Business:

a) Spill Co-op Boundaries: There have been no changes to the spill Coop Boundaries.

b) Spill Co-op's Memberships: The following is a recap of the membership fees in each of the Spill Co-ops:

Area Coop-1 – There are 71 members in Coop 1 that have Saskatchewan operations, of those 71 members only 30 members have operations in Saskatchewan. Out of the 71 Sask members 58 members have paid and 13 have not paid for 83% paid

Area 2 – 93 members invoiced, 82/93 paid members and 11 unpaid members for 88% paid.

Area 3 – 50 members invoiced, 36/50 paid members and 14 unpaid members for 72% paid.

Area 4 & 5 – 92 members invoiced, 83/92 paid members for 9 unpaid members and 90% paid.

Area 6 – 8 members invoiced, 7/8 paid members and 1 unpaid member for 86% paid.

Area Coop 1:

Sask members in attendance at the Winter Exercise: 30/71 for 42%

Sask members in attendance at the Lake Exercise AM Session: 12/71 for 17%

Sask members in attendance at the Lake Exercise PM Session: 10/71 for 14%.

Overall attendance in 2024 for Saskatchewan members in Co-op 1 (*note*this includes any additional representation of members at other Co-op exercises in lieu of attending the Co-op 1 exercises): 46/71 for 65%

Area 2 –Had a May exercise and had 75 people attending, representing 47 member companies. Area 2 had 47/82 members for 57% representation.

Area 3 – Had a June exercise with 79 people attending, representing 26 companies. Area 3 had 26/50 members for 52%-member representation.

Area 4&5 – Had May exercises and had 239 people attend representing 41 member companies. Area 4&5 had 41/83 paid member companies attend the training for 49% representation.
